Whereas

And Whereas

Himachal Chamber of Commerce and Industry is Public Limited Company, Incorporated under the Companies Act as Company Limited by Guarantee. It is classified as Non-Government Company and is registered at RoC- Himachal Pradesh.

Govt. Degree College, Kaffota and Himachal Chamber of Commerce and Industry, Paonta Sahib therefore agree to establish a programme of collaboration in the areas of mutual interest, and in accordance with terms and conditions set forth in this Memorandum of Understanding (MoU).

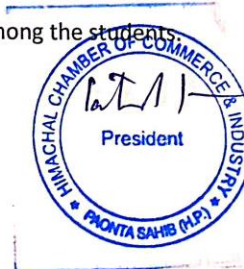
B. Collaborative Programme and Activities
