



The AR Department, Govt. of HP has again requested to login/monitor the online RTI-Portal at least once daily to avoid delay in handling RTI Applications and to dispose of all received/pending RTI Applications and Appeals as per RTI Act and Rules in a time bound manner. Further also informed that if any PIOs & FAAs of the department do not have credentials (user ID & Password) to login to the online RTI Portal, the same may be conveyed to their department with the detail of PIOs & FAAs.

In view of above, it is directed that necessary directions in the said matter has already been given to you vide this office letter of even number on dated 02.08.2023 & 29.08.2023. 


